Directions: The park is located in downtown Arlington on Olympic Ave., between 1st & 3rd street and West, just off SR9 and between SR530 (exit 208) and SR531 (exit 206).

Set-up: Friday set-up will be 10 AM to 5PM. Saturday set-up begins at 7am. Set up **must be completed** by 9am and all vehicles parked in proper areas.

Parking: Parking will be available in the parking area south of the park and on the corner of West and 3rd streets. **Please** use these areas to park your vehicles as this allows the general parking lot north of the park for the public.

Security: There is a police station close by and they make some rounds. The AAC is not responsible for your art, so if you are uneasy leaving your art in the booth, you can take it out when the show closes at 5pm.

Juried Show: **This show is open to those who are 18 years and older.** NO manufactured goods are accepted, product must be hand made by artist. Previous artists need not be juried in again.

NEW VENDORS ONLY: please send or e-mail photo(s) of your work to information below. Do not send check with inquiry-you will be notified.

Booth Fees: 10x10 space \$50 for AAC members and \$75 for non member. Booth sharing is allowed (limit to 2 vendors), but both applicants need to sign forms.

Cancellation Policy: You will be refunded half of your booth fee if you cancel out by August 20, 2021. No refunds after August 22, 2021.

Silent Auction: In lieu of the raffle we are changing things a bit from the raffle to a silent auction. We ask the vendors on a voluntary basis to contribute only **1 item** and it will run Saturday and Sunday until 2 pm. The winners will be announced at 3pm and need not be present to win.
