Set-up: Friday set-up will be 10 AM to 5PM. Saturday set-up begins at 7AM. Please be finished by 8:30 and all vehicles parked in proper areas.

Parking: Parking will be available in the old Dwayne Layne lot on the south side of 3rd street. **Please** park your vehicles in these spaces or in the public parking area south of the park.

Security: There is a police station close by and they make some rounds. The AAC is not responsible for your art, so if you are uneasy leaving your art in the booth, you can take it out when the show closes at 5pm.

Juried Show: This show is open to those who are 18 years and older. NO manufactured goods are accepted, product must be hand made by artist. Previous artists need not be juried in again.

Booth Fees: 10x10 space \$50 for AAC members and \$75 for non member. Booth sharing is allowed (limit to 2 vendors), but both applicants need to sign forms.
