Juried Show: This art and fine craft show is open to those who are 18 years and older. No manufactured goods are accepted; products sold must be made by the artist. Previous artists need not be juried in. New applicants please submit by mail or email photo(s) of your work to Berta Baker (information below). Do not send money with inquiry, you will be notified.

Booth Fees: you will have a 10x10 space, cost is \$60 for AAC members and \$85 for non-members. Booth sharing is allowed (limit to 2 vendors), both applicants need to sign the form. Vendors must provide their own tables and chairs, display racks and grids. Tables must be fully covered on all sides visible to the floor.

Payment: Make payable to Arlington Arts Council and mail to Berta Baker at 4609-190th St. NE, Arlington, WA 98223-4790. Deadline is August 16, 2025.

Set-up: Friday, August 22nd set-up will be 10am to 5pm. Saturday set-up will be as early as needed for you to be completed and ready for the show at 10am. All spaces are pre-assigned so check with Berta at her booth. If you have a request, let us know, but please realize we may not be able to grant all requests and reserve the right to place vendors where we may deem necessary. Please, park your vehicles in the public parking area south of the park or in the city lot on the south side of 3rd Street/ West Avenue

Security: We will have security Friday and Saturday nights (8pm to 6am) each night. If you feel uncomfortable leaving your art in your booth, you may take it with you when the show closes at 5pm. Never-the-less, the AAC and the City of Arlington are not responsible for any merchandise stolen or damaged. We urge you to carry your own insurance to cover any loss.

Cancellation Policy: You will be refunded half your fee up to August 16, 2025. NO refunds after August 16, 2025.
